ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Sanitary Sewer Extension Project: Contract No. 2 will be received, by the Town of Pomfret, at the office of the Board of Selectmen, 5 Haven Road, Pomfret Center, Connecticut, 06259, at 11:00 AM local time on Thursday, April 26, 2018, at which time the Bids received will be publicly opened and read. The scope of work includes, but is not limited to, the construction of wastewater pumping stations of varying sizes and configurations, along with associated site amenities and improvements. The work also includes site and process piping modifications, instrumentation systems, electrical upgrades, paving and site restoration. The required contract completion period is 365 consecutive calendar days.

Separate Bids will be received for Contract No. 1 – Piping and Contract No. 2 – Wastewater Pumping Stations. Bids shall be on a unit price basis for Contract No. 1 and on a lump sum basis for Contract No. 2. Contract Nos. 1 and 2 include additive alternate bid items as indicated in the Bid Form.

Bidding Documents may be viewed and ordered online by registering with the Issuing Office at **www.BidDocsOnline.com**. There is a refundable deposit of \$75.00 per set payable to BidDocs Online, Inc. Deposits may be electronically paid or must be a certified or cashier's check. Bidders requesting Contract Documents to be mailed to them shall include a separate check for \$40.00 per set for UPS Ground (or \$65.00 per set for UPS overnight), payable to the BidDocs Online, Inc., to cover mailing costs. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

Bidding Documents also may be examined at the office of the First Selectman, Town of Pomfret, 5 Haven Road, Pomfret Center, Connecticut 06259, on Mondays through Thursdays between the hours of 9:00 AM to 3:00 PM, and the office of the Engineer, Weston & Sampson, 273 Dividend Road, Rocky Hill, Connecticut 06067 on Mondays through Fridays between the hours of 9:00 a.m. and 5:00 p.m.

A pre-bid conference will be held at 10:00 AM local time on Thursday, March 29, 2018 at the Pomfret Town Hall, 5 Haven Road, Pomfret Center, Connecticut, 06259. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instructions to Bidders.
