- VI. CITIZEN'S COMMENTS: John Bala of 80 Covell Road spoke to the commission regarding complaint he filed regarding Charles Franklin. He submitted before and after photos of the Franklin property to the commission. He wanted to know the status of the complaint. D. St. Martin said they held a special hearing on 8/20/14 and the commission is waiting for an application regarding this issue. - A. Outstanding NOV (Notice of Violation)
  - 1. Charles Franklin II, 112-114 Covell Road. NOV issued 8/11/14 for clearing of wooded upland. No one was present to speak for this issue. On 8/25/14, Jamie did a site walk with Mr. Franklin. He spoke with the landowner regarding remediation. Also present was Eric Johnson, a forester. They will be submitting an application to the Town of Pomfret in the near term. If it doesn't arrive soon, commission will follow up. No work can be done with a permit from Staff or the Commission. After further discussion, it was decided that the best course of action is to leave the NOV in place (9/3/14). Leave on agenda.
  - **2. James D. Carter, 173 Babbitt Hill Road, timber harvest in upland review area.** NOV issued 5/29/14. Nothing new (9/3/14). Leave on agenda.
  - **3. Gayle Champagne, 39 Bosworth Road**, NOV issued 5/2/14 for work within the upland review area.

Jamie updated the Commission on this issue. He sent information to the Army Corps of Engineers. There is no sign of removed material anywhere on site. The Army Corps of Engineers will go over the material, call Staff, do a site visit, and then make a decision as to who has jurisdiction. This area is over 5,000 ft. Jamie spoke to the landowner regarding the issue of the stream channel being filled and a new on created. She has contacted KWP with no return call received yet. We will wait on the Army Corps to make a move/decision. D. St. Martin asked if there was any imminent danger should a storm arise. Jamie said more sediment would hit the Mashamoquet. There is no quick fix; the volume and velocity are too quick for a check dam at the bottom. D. St. Martin asked Jamie to keep the Commission in the loop. Jamie said he would (9/3/14). Leave on agenda.

- **4. Roger Daigle, 193 Putnam Road,** Cease and Desist **issued** 10/4/07. D. St. Martin read into record a letter from the Town Attorney regarding an update on the course of action regarding this issue (9/3/14). Leave on agenda.
