# INLAND WETLANDS & WATERCOURSES COMMISSION REGULAR MEETING MINUTES (AMENDED) WEDNESDAY, MAY 6, 2015 @ 7:00 P.M. POMFRET SENIOR CENTER

- **I. OPEN REGULAR MEETING**: David St. Martin opened the meeting at 7:00 pm.
- II. ROLL CALL: Present –David St. Martin, Vice Chairman; James Rowley, Secretary; Joseph Stoddard, Member; William Gould, Member; John Bergendahl, Alternate; Staff: Ryan Brais, WEO; and Jamie Rabbitt, Designated Agent. Absent: John Folsom, Chairman; Paul Safin, Member; and Nancy McMerriman, Member.
- III. SEAT AN ALTERNATE AS NEEDED: John Bergendahl was seated.
- IV. ITEMS TO BE ADDED TO AGENDA: None.

## V. PENDING APPLICATIONS:

- A. Deborah & Paul Simpson, 64 Hampton Road, septic system repair and landscaping. Mr. Simpson was present and submitted a letter requesting a 65 day extension due to wet ground conditions. J. Bergendahl made a motion to approve the extension. J. Stoddard seconded the motion and it was approved unanimously.
- **B.** Jamie Herrick for Keith Stolarek, 4 Amanda Circle, install 18' x 36' in ground pool and 4' high fence with self-closing, self-latching gate. J. Bergendahl recused himself from this application. Jamie Herrick was present for the applicant. Jamie Rabbitt said the area where this is has been maintained as lawn, and the pool is 240' from the property line and 65' from wetlands. He recommends that the conservation easement be delineated in the lot closest to pool. This area is relatively flat and no grading is needed. It is proposed to be in the lawn area, so they should put in three 4x4 posts with easement signs on the property, one of them to be at the angle change. W. Gould made a motion to approve the proposal as presented by Jamie with 1 conditions of approval to have the posts laid out by a qualified surveyor. J. Rowley seconded the motion and it was approved unanimously.

Kevin Corbin of Mashamoquet Road spoke to the commission regarding his property. He came to ask the commission about removing invasives from his property. He said he doesn't want to disturb anything. Jamie said there is a provision to allow an owner to remove invasives and the do one or two brush hog episodes per year. Jamie will look for the conditions of approval for G. Peservich and contact Mr. Corbin with this information.
