Amend Section 4.2.6 as follows"

4.2.6 Retail outlets for agricultural/horticultural products, where 50% of such products are grown on site.

Amend Section 4.2.12 as follows:

4.2.12 Farm Wineries, Farm Distilleries and Farm Winery Restaurants

Amend Section 12.8 as follows:

12.8 Farm Wineries and Farm Distilleries (Special Permit Required).

12.8.1 Farm Wineries - Definitions and Standards. A farm winery shall be any place or premises in which wine is manufactured and sold and which is located on a farm that includes at least five acres dedicated to vineyards or to the growing of other fruits used on site for creating wine. For purposes of these Regulations, the term "wine" shall include any alcoholic beverage, including brandy, obtained by the fermentation of the natural sugar content of fruits, such as grapes or apples. A farm winery permit issued pursuant hereto shall authorize the permittee (1) to sell wine in bulk from the premises where the wine is manufactured pursuant to such permit; (2) to sell wine manufactured on the farm winery premises to a retailer in original sealed containers of not more than fifteen gallons per container; (3) to sell or deliver such wine to persons outside the state; (4) to offer free samples of such wine to visitors and prospective retail customers for tasting and consumption on the premises; (5) to sell at retail from the premises sealed bottles or other sealed containers of such wine for consumption off the premises; and (6) to sell at retail from the premises wine by the glass and bottle to visitors for consumption on the premises. No farm winery permitted hereunder may sell any such wine not manufactured in such winery. The farm winery permittee shall produce within the state an average crop of fruit equal to not less than fifty-one per cent of the fruit used in the manufacture of the farm winery permittee's wine. An average crop shall be defined each year as the average yield of the farm winery permittee's two largest annual crops out of the preceding five years, except that during the first seven years from the date of issuance of a farm winery permit hereunder, an average crop shall be defined as three tons of grapes for each acre of vineyard farmed by the farm winery permittee.

12.8.2 – Farm Distilleries – Definitions and Standards. As used in this section, "farm distillery" means any place or premises located on a farm property in which distilled spirits or alcohol are manufactured and sold. A farm distillery permit issued pursuant hereto shall, at the single principal premises of the farm distillery, authorize (A) the sale in bulk by the holder thereof from the premises where the products are manufactured pursuant to such permit; (B) the sale and

shipment by the holder thereof to a retailer of distilled alcohol or spirits manufactured by the farm distillery permittee in the original sealed containers of not more than fifteen gallons per container; (C) the offering and tasting of free samples of such distilled alcohol or spirits, in amounts not to exceed two ounces per day per person, to visitors and prospective retail customers for consumption on the premises of the farm distillery permittee; and (D) the sale at retail from the premises of sealed bottles or other sealed containers, in amounts not to exceed four and one-half liters per customer per day, of such distilled alcohol or spirits for consumption off the premises. No licensed farm distillery may sell any such distilled alcohol or spirits not manufactured by such distillery. The farm distillery permittee shall grow on the premises of the farm distillery or on property under the same ownership and control of said permittee or leased by the backer of a farm distillery permit or by said permittee within the farm distillery's principal state an average crop of fruit or crops equal to not less than twenty-five per cent of the fruit or crops used in the manufacture of the farm distillery permittee's distilled alcohol or spirits. An average crop shall be defined each year as the average yield of the farm distillery permittee's two largest annual crops out of the preceding five years.

A farm distillery shall:

- a. A farm distillery requires a minimum parcel size of 5 acres, or may be comprised of more than one contiguous parcel under the same ownership totaling 5 acres.
- b. A farm distillery may also contain an area for the retail sale of agricultural/horticultural products, where 50% of such products are grown on site or on other property owned by the operator of such retail outlet located elsewhere within the Town of Pomfret.
