I am expecting that one of these days though someone will roll up and be concerned because I say in the ad that the greenhouse is very quiet which it is because it's in the same parking lot as the ice cream stand which the nice day that we had last weekend was anything but quiet I mean there were like 100 motorcycles at the at the stand last weekend because a group happened to roll through and it was, it was shockingly busy. But you know we keep the distance at the greenhouse so it's it's not. It's not that big concern but I am very concerned that it's

So the last thing I wanted to do, to Linda show which is already triple complicated, is to throw up little vegetable Stan table there that people had to get out a line for, they had to put dirt up on the counter for me to make 50 bucks a week on vegetable seedlings so I'm going to return most of those flats that I got from. Cool.

There's really no way in my mind that you can dictate appropriate social distancing at a market like that, ya know, so I don't know how to do it you know if the markets dead. Then it's not worth your time to be there, and everybody will be effectively socially distanced. Yeah,
