- **I. Regular Meeting Open Meeting –** M. Nicholson opened at 7:00 PM.

- 2. General Discussion A revision to the Constable Policy was discussed that would specify the wearing of uniforms. The current policy does not address this at all. The State has withdrawn the funding for an Environmental Depot due to lack of commitment by sending towns. NECCOG is applying for a similar grant that will identify definitive costs in operating such a facility, allowing for informed decisions by participating towns. A new Assessor has been hired and she will start on Wednesday.
- **3. Project Updates** The Sewer Project is nearing completion and the Selectman's office is looking into the final bonding for the project. The DOT is meeting with M. Nicholson for a ramp review on the sidewalks. The grant for the EOC is closing out and a grand opening will be scheduled in a few months.
- **4.** Tax Refunds/Abatements: Laurie Payne Steiger, COC, \$102.33 M. Nicholson moved to approve as presented. E. Chase seconded. All in favor.
