- b. Nomination for Lois Orswell Award The commission received a nomination for the Lois Orswell Award and there was mention of another possible nomination. These will be discussed at the next meeting. There was discussion about who can be nominated.
- **c.** Last Green Valley Cleanup The Commission will give the information to Deb Mansell at PCS for her group's consideration.

- X. Citizen Participation There was further discussion with Sean about staff and trash pickup, bulky waste, trash cans in various locations and the town wide annual cleanup.
