Grants Fund 5 Electric Vehicle Chargers for Pomfret


Working with Titan Energy, a Pomfret EV Charger installation project was designed, and applications submitted for funding. One grant awarded was part of \$6 million received from a legal settlement in a Volkswagen Corporation emission cheating scandal. Pomfret was the only municipal grant recipient in the Quiet Corner for the VW funds. The second source of funding is from the Eversource EV incentive program. Together these funds will cover the <u>total</u> cost of the chargers.

The project will allow the town to install four dual-port, level 2 chargers and one duel-port DC fast charger in town at <u>no cost</u> to the town. These ports will be located at the Community Center on Mashamoquet Road, the Pomfret Town Hall on Route 44, the Pomfret Library also on Route 44, and the Pomfret Community School on Pomfret Street.

Several years ago, a double level 2 charger was installed at Town Hall with grant funds. That charger experienced a breakdown and is no longer working. Replacement parts are not available. A fast charger will replace the nonfunctioning unit. Publicly accessible Level 2 chargers will be installed at the Community Center and the Pomfret Library. Two Level 2 chargers will be installed at PCS for employees only and will not be listed on apps for public use. There will be a working group to determine the cost associated with the charging stations and the revenue that will come back to the town. This project is moving quickly and installation at the Community Center and Pomfret Community School should be completed before the end of the year. The Town Hall and Pomfret Library sites may take a bit longer due to the necessity for Eversource to install new poles at those sites. The existing poles are aging out.

In 2015 Volkswagen admitted to utilizing defeat devices to cheat emissions tests and deceive regulations on the state and federal level dating back to model year 2009. The deception violated the Clean Air Act and resulted in a federal civil enforcement case that brought \$55.7 million to Connecticut to fund initiatives to offset the emissions over a ten-year period. With the \$6 million in 2023, Connecticut has now invested \$35 million of the settlement in more than 100 clean air projects statewide. The money will fund a total of 54 electrical vehicle supply equipment (EVSE) projects throughout the state.



Transfer Station Construction has Begun.

Pomfret's new transfer station is showing progress! The grading of the site has begun, and construction will continue until the weather prohibits progress. 
