The commission approved this originally for 24 spaces and the encroachment. There is a need for a PE to sign off on the grading plan. It is ok if they reduce the parking to 21 spaces because the commission approved 3 different parking plans. He also stated that there would only be 2.5' of fill. Jamie spoke with B. Woodis and M. Nicholson. The library is contemplating an expansion. They are awaiting solidifying expansion plan and then will come back to the commission regarding the parking issues.

There was a huge tank near it and now the tank seems to be half in the ground. Someone will go out and check it out.
