### Update on property acquisition

#### **Update on grant**

We were awarded \$481,000 (50% of the projected costs) by the State of CT. We have 3 years to do the fund-raising and 1-1/2 yrs. to begin construction.

#### **Fiber Internet and CEN**

State Library is encouraging schools and libraries to convert to CT Educational Network (Fiber optic line). Charter cable line will be replaced by the Fiber Internet. Price for annual maintenance has dropped from \$3600 to \$300 per year! Bandwidth is \$125/mo. We can apply for a Federal subsidy which cuts cost by half. Currently we pay \$740/yr. for cable. Fiber will be \$900, same bandwidth. Can increase bandwidth later if we find we need it. Total would be \$900/yr.

SR Move to change internet service from cable to Fiber. LC seconded. Approved.

### 2019 Budget

Need to submit it to the First selectman. Finance committee will prepare the FY2020 budget, we'll meet on Wed. Jan. 16 at 5:30PM to approve. (Special Meeting)
