Hello everybody and welcome to our first virtual Board of finance, special meeting since we've never done this before. They're with me. First of all, if anybody is on the. Also on their computer watching us. There will be time for you to ask questions during the citizens participation. We request that you post your questions on the chat feature, you can do that at any time. And that way, the questions will already be there. When we get to that. Okay, all six of us are here. Myself margay hobby Danna flat, Jill Corey, Elaine SISTAR Debbie Thompson, and Jennifer York. We had our budget workshop cancelled so we haven't had a chance to get together and talk about the two budgets that were presented to us. Earlier, I guess back in the beginning of March. Today, we, we also were sent a revised draft of the general government bad budget. Everybody get that. Yep. Oh,

So perhaps when we, when we get to that, I can ask Maureen just to summarize

a couple of points I wanted to make.

And, and you probably already know all this stuff but I'm just going to repeat it. Our unassigned fund balance right now is at \$1.7 million, which is 13%. Our goal is to have it closer to 10%. And to get there. That means we have about \$360,000, that we can use if we so choose. That money we would be using for one time capital expenses such as the Woodstock Academy. Capital Improvement fee.

And also to lower the tax rate.

Now we're expecting some money to be turned back by both the town and the school at the end of this fiscal year. So that will be a plus and that will be very helpful for this next year and for subsequent years budgets are expected to get tighter. In the next few years. I want just gonna make two other comments about the budgets in general, the general government budget has been has been minimal for the past

10 years. And we can't keep cutting it because we won't be able to support the town and the infrastructure. I personally would like to keep the general government budget increases zero. The board event has a lot of expenses that are non negotiable. They are set. But I'm also concerned that that budget has grown quite a bit in the last 10 years almost \$2 million. And at the same time enrollment has dropped. So I think you're all pretty much aware of that. I had a couple of ideas for what I was looking at for where we could go from here. The grand list has an increase of about \$100,000. That's one good thing. There is unanticipated educational cost sharing ECS money that we didn't realize we're getting more than we thought we had budgeted for, that's about 88,000. Then we have about, I believe about 100,000 on anticipated revenue the building permits, that type of thing. The Board of Education feels that they can return. About \$125,000 to us this year. So those are all very good things. Now, I mentioned the unassigned fund balance at 1.7. The Board of Ed non lapsing surplus fund. July 30 2019. It was \$201,458. Now we transferred \$62,403. In October, I'm not sure when that actually goes in, but that was added to that which gives you a balance of 263,861. So the that's some of the money that we have to work with. Now again, the general government budget I was dealing with the number was \$2,856,036.

okay that original number did not include the Woodstock Academy capital improvement fee, so I added that in, and that was approximately \$79,788. So that brought the general government budget up to \$2,935,824. That's a net increase of about 100 a little more than 180,000.

again, my the figures that I have written down, are not up to date because of this new she's already taken that amount out. So, what's your question. Bias paying for covering the salt shed, and the capital improvement fee, with money from the unassigned fund. That would be over 100 209,788.

Cutting \$100,000 from the number they gave us,

and taking money from the non lapsing surplus fund and taking money from the unassigned fund that would total 300,000. So that would be \$100,000 cut and \$300,000 from those two funds maybe half and half hundred 50,000. That would leave an increase of \$26,507. So I'm throwing that out for discussion.

And I've had this conversation with with Kate and other people that if we had to go to a number like 200,000. If I had to go bigger than 100 that I have to do personnel, which would not be good for us to do so the hundred thousand is doable. Okay. I think my only concern becomes the amount taken from the non lapsing. I had raised the same question of the balance of the non lapsing because the hundred thousand from last year actually hadn't been moved into my conversation with Bonnie right, and she said the board of finance took action. So whether it's moved or not, it's technically it's out of there at some point. So that hundred thousand gone so now it

could be restored maybe I don't know but it was 163, and you took 150 out of that you leave \$13,000 at that point there that's designed for unanticipated special education costs, primarily in unanticipated capital projects I'd be concerned to go into a school year, with only \$13,000 into that account. Okay, obviously I appreciate the fact that if our budget is done at 100,000, we can maintain our staff we can maintain our programs will go forward. And that's the best part of this. The concern becomes an issue no, the students move in the students without the special education costs are crazy. So, that number going down to 15. That's why I said we work pretty hard if you talk to me. A month ago what our balance would be we probably were talking more 50,000 okay because you don't know how the accounts are going to work out. I've only got two months left. All right, So if somebody now picks up health insurance. I've only got two months of health insurance to pay so I can pretty much free up that account. I have some spring activities that aren't going to happen. Whether it's tomorrow or the next day Friday at some point they're going to announce I'm convinced there's analysis schools are not going to open up. All right, and in effect so there are some savings there not as much as you might think. But there's some money there that can do that. So therefore, recently we've really crunched the numbers we've gone from what we said might be a \$50,000 surplus up to 125,000, the good news with PCs is that 86 or \$88,000 there back I think was Deb's question earlier on the budget. Right now the legislature is not in session. Okay. Did you have a two year budget. If the budget goes through as passed a year ago. The difference between what the board of finances budget in ECS this year to what you will get next year is about a \$12,000 increase it's not a lot of money okay from the number you got this year to next year's number is a decrease but because of the fact that you sort of split the baby last year in the numbers the number, you're getting better revenue the number was lower is a \$12,000 increase. So, there are some revenue parts that I think are helpful that 88,000 maybe 12. So the hundred thousand dollars at the board event can work with very well, we will not have to lay off staff, just to concern how deep we go into that and maybe some consideration. I'm two months away, save 125 became 140 or 145. Could the additional money, possibly go towards back into that fund, because one student. One student can easily be \$100,000.

We've been we've been crunching these numbers every single day, we got nothing else to do lately so we're crunching numbers and, you know, I'm gonna say the hundred and \$25,000 is a definite figure, could be a little bit higher. Okay, I'm not gonna hold my breath on that, but the hundred 25,000 is a real number. Okay.

And I asked a question. This is Jen York I'm just wondering, the hundred and 63 861, that's in the non lapsing now is is that include the 125 that you're talking about.

No, no, there's no such thing as separate the money's already there, that's sitting in that room and what I'm talking about. 125,000 is at the end of this year we get to June 30, usually Well, our finances probably aren't wrapped up till September one that's when you file with the state of Connecticut. And usually when we get to the end of the year, we have a project that we have a balance of a real number. And then we usually write to the Board of finance to say okay we have \$50,000 left this year as a surplus would you consider putting that into the non lapsing fund. And that's Board of finance decision whether to do it. What I'm saying right now is that when we get to that point when the budget is done we're gonna have \$125,000 surplus in not be asking the board. The board of finance to put it into the fund, we're saying that's \$125,000, that the Board of finance can consider putting to offset the mill rate for next year. Okay. Thank you,

Steve. This is Debbie Thompson, I have three questions, and I know at least one of them is going to sound harsh but I'm just throwing this out here first of all, is there any conversations amongst sending towns about reducing the tuition increase to Woodstock Academy.

There's always conversations about reducing tuition, I will tell you and I think I had this conversation with Kate thrown and Maureen and margay I always had a superintendents meeting in a different part of the state, where the students go to other high schools, other than Woodstock Academy in 19 97% of the conversation was how outrageous is the tuition that they're paying to the high school that they're sending to be at Norwich free Academy or, or anywhere else. I, I do not believe that the Academy is in a position to lower its number. In fact, they're going to have issues which are beyond me. I, if I were them I'd be concerned about boarding students returning, and I'd be concerned about boarding students, an increase of, especially from out of the country maybe from inside the United States. So they've got that some of their capital plans, they're going to have to wind up doing in their estimation. They, they say that we are not paying their for their full per pupil cost. Okay, even though we're paying next year it's 15,000, I forget the exact number 15 515 eight whatever the number is, they would say their real intown per pupil cost is over \$17,000 \$18,000 in their per pupil doesn't include the special ed does include transportation etc. So they in their opinion we are underpaying already. Okay. And in effect their board of trustees has done two things. They've instituted the capital fee which quite frankly they probably should have done 20 years ago, they should have done \$100 a year per kid 20 years ago they might not be in the position they were in. And they said over time what we're going to do is that we are going to move over a 1234 year period to get closer to the actual cost, and that's why the escalation in the last two years has been so significant if you went back. Eight 910 years ago the increase at the Academy in terms of per pupil tuition was not significant. The last two three years it has been so I think all the towns have the same issue the same problem. There's very little power to do anything about it, their board of trustees is more like a board more like a college board, and therefore that that College Board of Trustees is saying, what are we going to do to improve the university or image our programs, and therefore, they put it out there that board is not responsible to taxpayers like the Board of

Education The Board of finance board, and, and, therefore, I don't think they see that as a significant problem. The other part I think is from a parent's point of view, educationally are the parents pleased with the offerings that the Academy is giving them. Absolutely. they are pleased with what they're getting, and therefore going to say yeah you know at \$15,000 a kid it's worthwhile, what the town is giving them.

I don't think I believe it's probably premature at this point to ask them, the union to open up their contract to and renegotiate. I guess I'll let Steve speak to that. So I mean, the answer is in the history we have done that before. I, I just don't know if we can demonstrate the kind of financial hardship yet, because it we're forecasting a financial hardship, we're not really in the midst of it yet.

not having been there for the history of it. But when I look at the contract many many years when the pumper contract was done. Teacher contracts usually have two components and their salary. One is a general wage increase and one is a step movement that movement is dependent upon possibly years of service and your degrees. Also, there have been so many freezes over the last so many years on step movement almost every contract has had that that I've had to create this grid because I have a part of the contract that tells me that I can't really hire anybody, new with equivalent experience have somebody with 11 years experience. I can't hire a new person with 11 years to put them at a higher step than somebody on my staff was 11 years of experience for the person coming in with 11 years of experience in a normal district expects to be on step 12, okay, for the following year. In Pomfret step, 11 years experience is probably Step five, six or seven okay because it's been held back so many times. So that might be the part I think the other part and that Kate was alluding to is that I see, I see probably the board the town going back to bargaining groups, but I'm not quite sure this is the year. Okay, this is the year and we're in a short period of time we're already into April with a budget, but just say that next year's budget, with the revenue or the following year because the state has this great drop in revenue if I'm sitting here looking at the Board of Ed is going to give back \$125,000 in knowing that I'm going to ask staff to not take any kind of a raise, ECS was at \$80,000 higher, etc. So right now the revenue part short term this year is probably about as good as you're going to get. Next year, the year after when the revenue starts to dry up. I agree 100% that's the part to go back and say to everybody. What can we do to try to make this work. Because if we don't make it work. We're going to wind up having, it's going to impact positions that's what education is it's people, and I'm going to wind up losing people which means service to kids.

Well, and I've just been listening, every day like a religion to Governor Cuomo who just had to do his budget in New York. Yeah. And he said the revenues are not there, and at the federal level the revenues aren't there and his biggest concern was education. Um, and he and I don't know in this state or in the town or whatever he's actually changed his budget over and got the legislature legislature to agree that it's going to be based on revenue so if revenues go up in the third quarter. The Hill tell them this is what you have, you know, he's not really locking them in but putting in some flexibility. And I guess in my mind in the larger overarching sense of New York's not gonna get a lot. And we know how hard hit they are, where does Connecticut fall on that continuum about getting money. And then Pomfret on that either further continuum in this state because the cities are going to get a lot first. So I would like everybody to have a piece of the pie. I just am unclear like with everybody else what that piece of the pie would be, but I would like to fairly give as much as we can, without putting us too far in deep, using the unexpended balance because we're going to have to use it next year and probably the year after, and that's my thinking behind my questions.

So over time we're trying to do that. So again if they were helped to get some of that done, that'd be great. In this particular year and what we're heading into someone says to me, we can't afford it this year I fully understand we can't afford it. At some point, I don't want to lose track of the fact that there are these ongoing things that we need to do to sort of maintain and keep the building going that's all but obviously in this cycle, and who knows what next year next year probably budget wise is going to be worse right now, we're looking to that there are some extra revenues and things that can be done. You know I think next year and the year after are the bigger problems for us right now, but he's sure in the future, if there's a way to say okay how do we build for the future, so that we can make sure that when this \$40,000 cooler or whatever a cooler cause a walk in freezer costs when it goes we can replace it without going to the Board of finance and saying, I can't keep food fresh and therefore I need \$40,000 as an emergency versus we built it up over time. And the purpose is saying that if and when schools open whether it's May June or it's next August, September, you want these bus companies to be functioning you don't want them to go out of business. And they're saying to us to negotiate an amendment to the contract for what they would consider fair and reasonable expenses and primarily they're looking at wages and health insurance. They want us to go back and say, of the amount of money we're paying to every day, how much is wages, how much is health insurance, they are telling us that we're to negotiate upon that that the vendor is to give us documentation as to what the wages and the health insurance they're actually paying and attest to it, that's the general from the executive order, the transportation companies have written as of last Friday to they started with the commissioner. And I'm not quite sure the commissioner of education is going to answer this I think it's ultimately going to go to the governor, and they're trying to say that they run out a small margin, and part of it probably is the fact that because they are private businesses. They're not going to open their books, and they're not going to tell you what they're paying people and then I can tell you the health insurance and I can tell their competitors, what they're doing, etc. The bus companies are looking for. And I don't blame them as a larger payment as they can get. Okay. And obviously the schools are looking to as little as they can get the bus companies are hoping across the state of Connecticut that the governor or somebody will issue an order that will say that from now to the

end of the year the unused days you will pay them pick a number, 60 7080 90% of what your payment is so they can pay their people keep their people on health insurance, etc. I'm not quite sure where it's going to land up what wind up, we're not going to get zero. I know it's not going to be zero. Okay. Um, if I were to say what I think that transportation number would be, I think the best is going to be will pay 80%. It could be his highest paying 100% of what the number is okay. And in terms of factoring out to the end of the year. We were looking more at that at Palmer. There are school districts that have engaged, various legal firms to send very detailed documents to the bus companies, demanding that and not too many but saying in order to negotiate you must show us this documentation, etc. I'm not quite sure how they're going to do it I don't know exactly where it's go but I would anticipate by the end of the year. We're going to pay at least 80% of the bus contract even though we haven't run the number of days, I wouldn't be surprised if it's 90 or 95%. So there are some savings we factored in some electricity savings. Some diesel savings, some, some fuel, some spring sports etc. But that is not a monumental cost the only one number if I didn't have to pay it at all. Transportation would be the big one, and that would produce a lot of money transportations about \$50,000 a month. So three months of no transportations on your \$50,000. I don't I'm planning where to pay at least 80% of that, if not more.

So Steve Can I see we're saying that they are all generally private companies. Is there a way to find out if they avail themselves of all of the monetary things that are out in the Kazakh right now. If they tell me this, the governor says is the number that's what the number is I think the number should be closer to 80% probably but that that's a conversation, I've had with our vendor to say that if there was any money that you got that we paid you full price at some point is any money you got through stimulus or whatever, then that money would then obviously be returned to the town. Right now, my understanding is that the comfort drivers are on workers comp. Okay, and therefore it's like I'm saying well if there are, if they're getting I'm sorry unemployment

unemployment. I'm just like, oh

my god, you're on employment, and you're getting maybe 50, or 60% of what it is, if I then pay you full price. Then I've overpaid you okay and I don't think there's a way to make the people whole who are there, although I had a conversation with our bus vendor today, and he said one of their proposals is

that if the driver, our drivers collect unemployment all summer long when they're not working. Okay, so they're saying if they collected for three weeks now and you paid me full price. In July, we'll pay them full pay for three weeks so they don't collect unemployment. So everybody is hold at that particular point. I'm not quite sure where it's going to end up but I do think the decision is either going to be made at a higher level, or it's going to be the okay corral across the state of Connecticut, with districts and their vendors.

It is the state of Connecticut. Okay. But back to Joel's question that's probably the bigger number, the other smaller things not running softball or baseball and the transportation that would go with softball baseball, we're factoring that into the hundred 20 5000s we've got that I haven't taken that \$50,000 for for April in may in fact add that in because I don't think we're going to save that kind of a number.

So I didn't want it to sound like we were asking for one to cover the other. The other point I wanted to make is that non lapsing fund is really, I think it was meant by the legislature to be a convenience to the town. Because the way that the Board of Ed budget is structured, we cannot build savings or anticipated revenue into our budget we're not permitted by the statute to have a revenue line. So for example, if we were to budget. The way other municipal entities budget we could say, Okay, listen, we anticipate a couple extra special education, you know implications. We're going to put \$100,000 into a certain special ed line item in one year have it available in the next year. We're not permitted to do that under the statutes. So whenever we have an unanticipated cost. It always comes in the form of an appropriation that we request from the town. So to avoid the town having to go to special appropriation. The statute the statute has built in this non lapsing fund. So it's really the convenience of the town that that is there. So when we budget. We keep an eye on not letting that non lapsing fund fall too low. Because otherwise, the way that things operated when there was no non lapsing fun we were going back to the town for anything over a certain amount, we'd have to call in a town meeting and and vote on any anything that was unanticipated. So for the convenience of the town so that you're not calling back in and, you know, special appropriation on a regular basis. That's why that is there. So, you know, and we've luckily been able to fund that often with money that we've returned. So, we were thinking in our, you know when the plan that the board had laid out and with Steve's direction, was that we understand that the 125 is needed now, I mean you you know you have a designated fund that's that's rather high However, these are these are really stressful times financially for the town which is why we were not asking, making any kind of request that it go into the non lapsing fund, however, to allow the non lapsing fund to fall to 13,000. It's not going to cover anything and when we have an unanticipated cost, you will be looking at a special appropriation, to a town, who is maxed out. And probably, you know, very upset at the need for a special appropriation so as a board of finance I just wanted you know to frame that question. In that way, if that's helpful.

The other part back to Kate's comments upon the undead and native thinking back to Superintendent school when they did the budgeting class Okay, they told you that when you budget for special education you budget for unanticipated special education tuitions and you put in tuition that would come out that DCF would might have given you, you probably put in it tuition that the court system would give to you, and based upon your experience you put in one two or three tuitions that might turn out from the family that moves in from out of town. Okay, so most budgets carry extra money in their regular operating budget for unanticipated special education tuitions that may happen in Pomfret. We budget real kids that we know about and in the people on my finance and budget committee know that a kid moves in the kid moves out and move in. Well, we do real kids real numbers etc We don't build it in the reason we don't build an extra is if I get the kid moves in I got \$163,000 sitting there to cover. I don't have to if I built in two tuitions a year. I'm building a \$200,000 extra every single year to cover it, as opposed to having 167 or whatever the number is, you have a fund that sits there and you don't want to giving in that extra money for the just in case that just in case is covered.
